### **ROAD TRAFFIC SAFETY MANAGEMENT SYSTEM**

**ISO 39001** can be implemented by organizations of all types and sizes, who wish to:

- Improve their safety performance on the road network (RTS)
- Establish, implement, maintain and improve the RTS management system
- Confirm their compliance with stated policy
- Demonstrate their compliance with ISO 39001

**ISO 39001** is designed for:

- Public and private organizations involved in road transport
- Construction and consulting firms
- Organizations with many vehicles
- Companies whose staff is frequently on the road.

#### **WHAT IS ISO 39001?**

Worldwide traffic accidents account for more than 1.3 million deaths each year. It is estimated that by 2030, injuries caused from road accidents will be the 5<sup>th</sup> most common reason of health loss worldwide.

Young people between the age of 10 and 24, are the most vulnerable with the leading cause of mortality (10%) being road accidents.

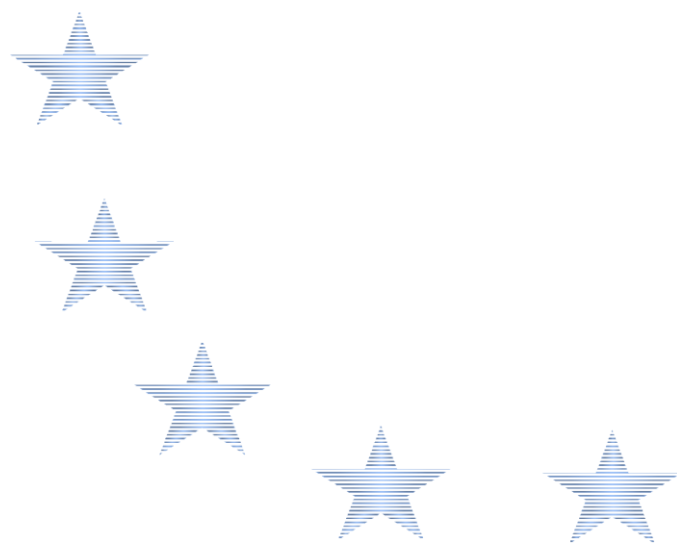
ISO 39001 is a complementary tool which aids road safety legislation implementation and which has been designed for organizations associated with road transport.

### **How long does it take to certify with ISO 39001?**

Typically 3-6 months, although this may depend on various factors. The main issue is that the organization demonstrates that its management system is fully implemented and meets all the requirements of the standard. Top management and employees' level of awareness is also a crucial point to determine the necessary time for gaining certification.

### **Does it substitute public authority audits?**

No. ISO 39001 is a voluntary certification aiming at continual improvement and does not substitute any public or official audit. However, it improves the company's organization, so that it complies with all relevant applicable legislation and helps avoiding any unexpected problems or fines during these audits acting pre-cautiously.
